This 2025 Patient Outcomes Report for Oregon highlights the effectiveness of outpatient Medications for Opioid Use Disorder (MOUD) treatment and demonstrates that:

Specialized, whole-person-focused treatment leads to positive recovery outcomes. In the outpatient treatment setting, results orientation is essential to the patient-provider therapeutic alliance and, together with medication and psycho-social support and guidance, is a key element of the treatment process.

At Community Medical Services, we will never discharge someone from care simply due to the outcome of a test result. Return-to-use is a normal part of recovery, with a focus on lesser use over time and harm reduction as the primary goal.

Overview

Our Patients

In 2025, Community Medical Services clinics welcomed 587 Intakes/Readmits at 2 clinics throughout Oregon. CMS patients in Oregon come to our clinics from 4 counties*.

Patients find CMS clinics via online search, referrals from friends and family, and community partner recommendations. To foster relationships with community stakeholders and encourage referrals, CMS actively conducts outreach in every community in which our clinics are located. We do this with a dedicated Community Impact team whose purpose is to serve as a bridge between individuals needing help and the treatment resources available to them, making it easier for people to receive the support they need. Their main priority is to create a positive impact in the communities they serve by living out our vision to “eliminate the consequences of substance use disorder”.

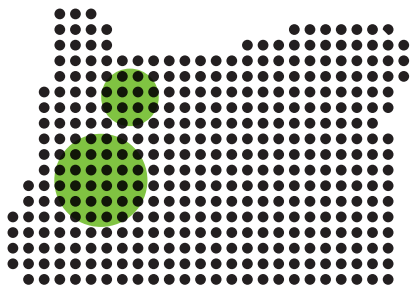
Community partners who refer patients to CMS include:

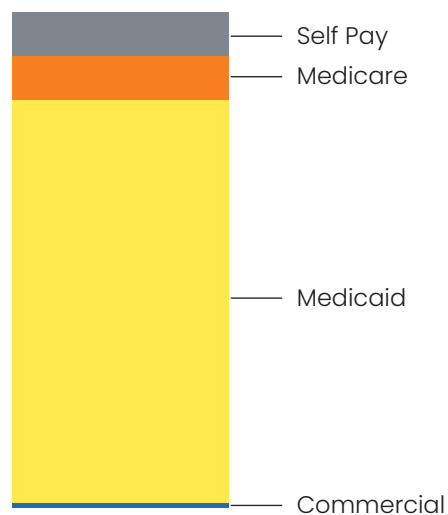
Active Patients by County

From January - December 2025, Community Medical Services completed 587 patient intakes for care at 2 clinics located across Oregon. The map shows patient census distribution by county of residence.



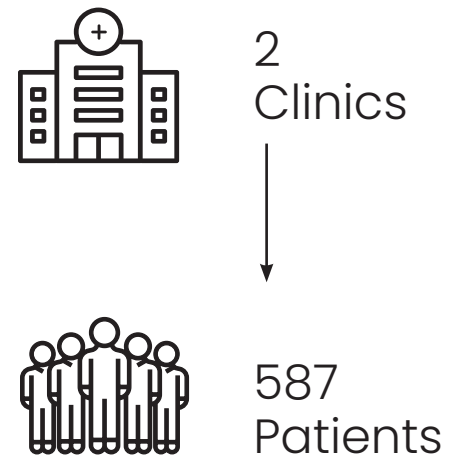
Payer Coverage

Geographical Reach

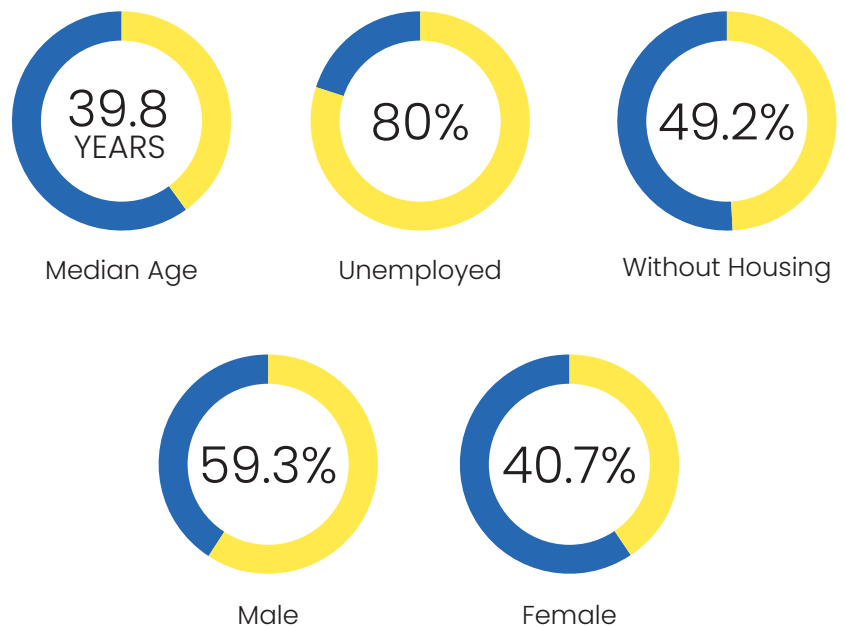
As of December 2025, Community Medical Services welcomed 587 new patients in 2 clinics located in Oregon.



Patient Characteristics at Enrollment

At enrollment, patient reported Social Determinants of Health (SDOH) in Oregon highlight the profound and intersecting challenges faced by individuals with substance use disorder. Many enter care experiencing housing instability, unemployment, and justice system involvement. Sustained, evidence based treatment—combining medication and behavioral health services—plays a critical role in addressing these challenges. Over time, treatment is associated with improvements not only in health outcomes, but also in key areas such as housing, employment, food security, education, and community connection.

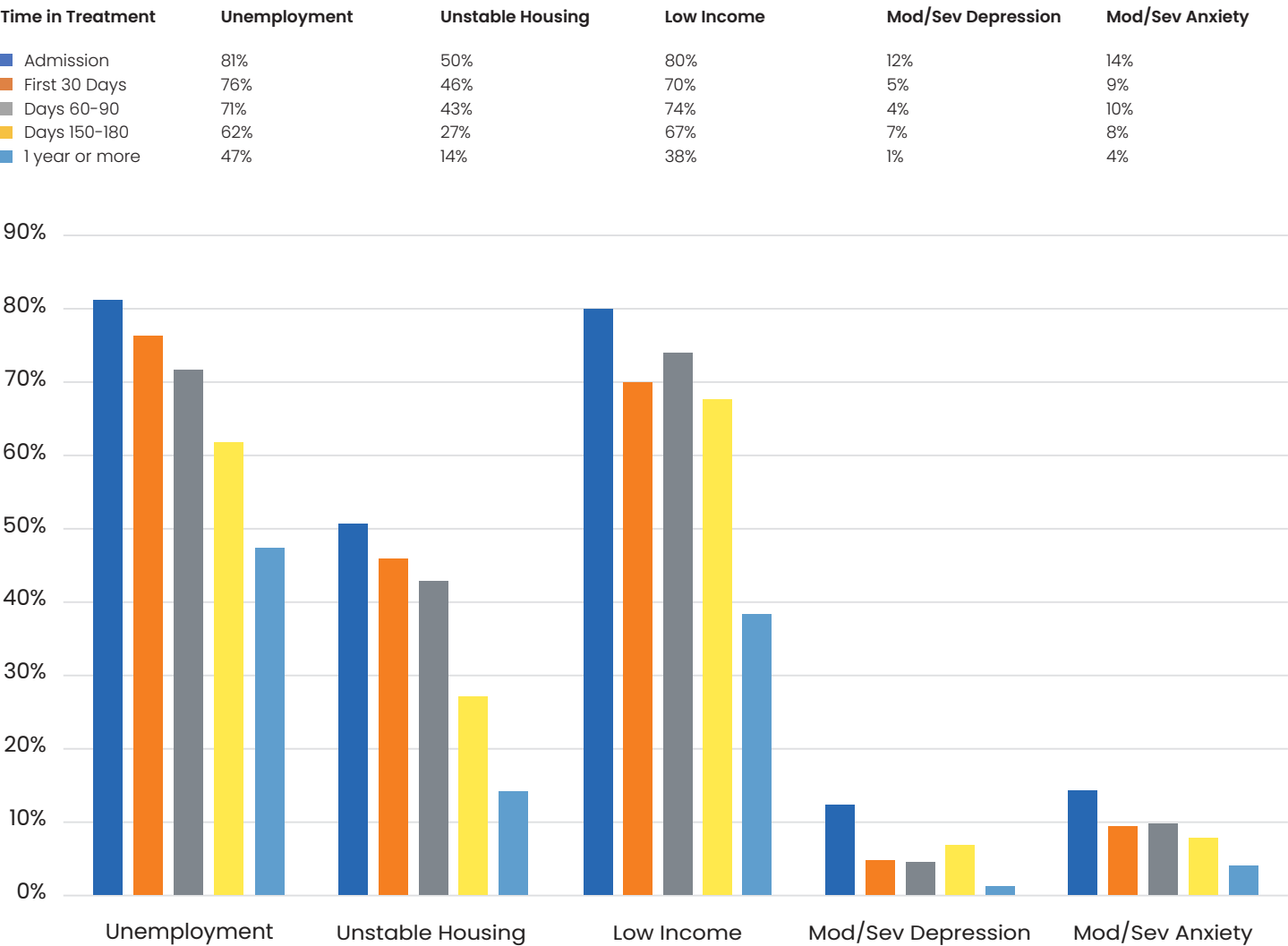

Our Patients Continued

Community Medical Services’ Oregon census increased at a cumulative annual growth rate of 340% between 2024-2025, due to the opening of Oregon’s 2nd CMS clinic in Eugene (June 2025).

Our counselors in Oregon have spent 1,503 hours directly counseling patients in 2025.

Community Medical Services has provided care to 705 unique patients in Oregon in the last year. We believe each of these patients will show the most improved outcomes over time with increased time spent with one of our licensed behavioral health counselors.

One of our core Values is, "We listen to and honor the realities of those we serve," and CMS counselors do just that - LISTEN. In 2025 alone, our counselors spent 1,503 hours providing customized counseling to 607 unique patients.

Revolutions in Addiction Counselling

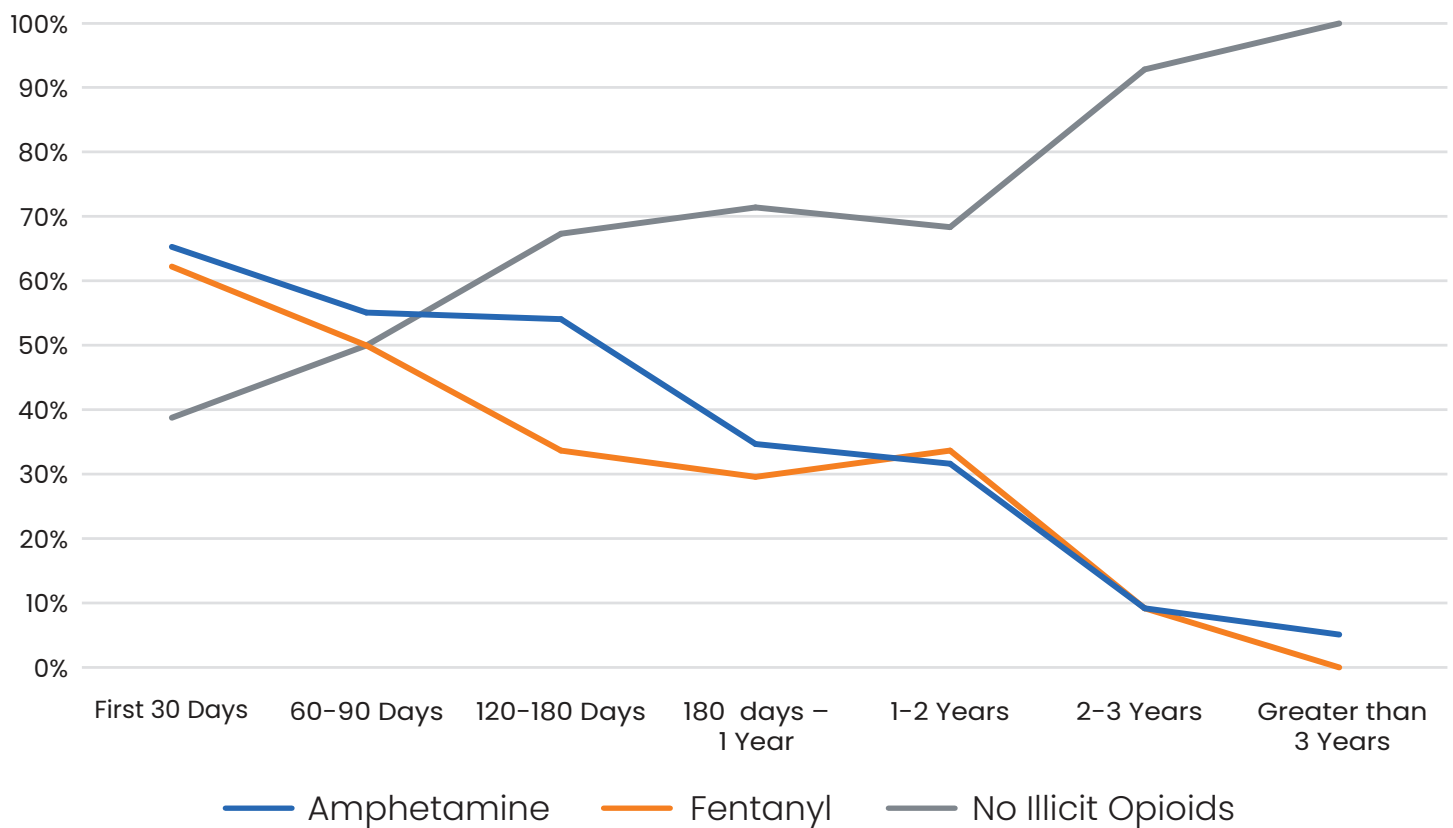
CMS patients who link with their counselor on Recovery Connect early in treatment are 55% more likely to remain in treatment after 30 days, and patients who engage with the app's tools and messaging features are at least twice as likely to stay in treatment than those who do not.

Recovery Outcomes

Fentanyl positivity declines the fastest and earliest after entering treatment, suggesting that access to stabilizing medications, counseling, and overdose risk awareness measures such as complimentary naloxone all leads to rapid reduction in use and need to use.

Amphetamine positivity declines steadily, but more slowly, with time in treatment. This is characteristic of behavioral stabilization over time. Stimulant use (especially methamphetamine) is often tied to habitual patterns to cope with mood, energy or socioeconomic stress, and the tools our counselors provide can begin to take hold and help manage these stresses, leading to decreased use.

Trusted Care for Readmissions

Recovery from substance use disorder is a long term process that often unfolds over months or years.

Care is delivered in a voluntary, outpatient setting, allowing patients to engage at an individualized pace. Return to use is a common and expected part of recovery, reflecting the varying levels of readiness to change among individuals. Our approach is grounded in meeting patients where they are—providing consistent, judgment-free support over time. This persistence on the road to healing is reflected in readmissions to our program observed in all clinics.

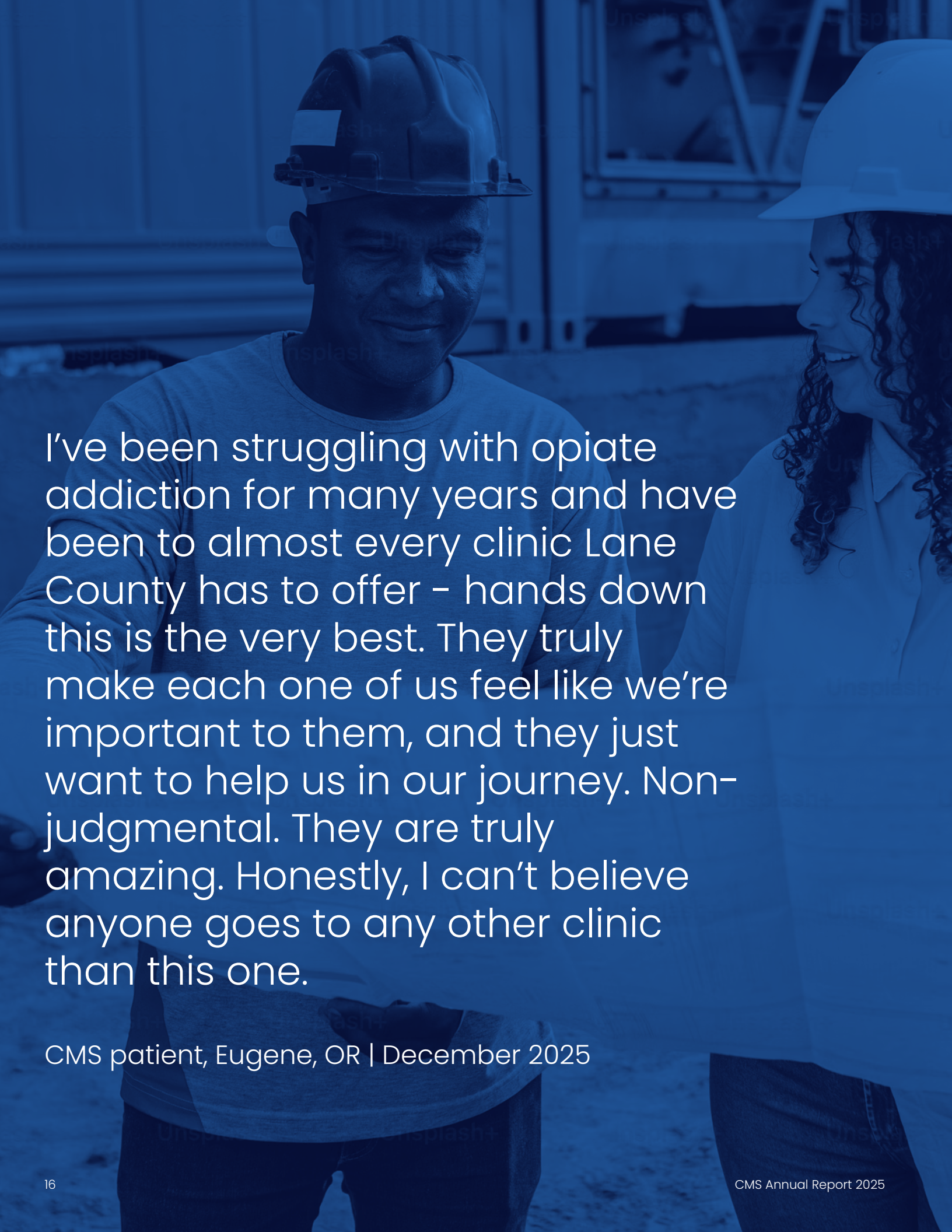
A “readmit” at CMS is defined as a person who was in treatment at a CMS clinic, left our care for 30 days or more, and has now returned to treatment. The consistency with which people return to care back with CMS counselors, providers and the rest of our incredible team is a testament both to patients’ resiliency, and to each of our team members making sure that person feels safe and welcome with us, whenever they are ready.

Our judgment-free environment keeps the door open to return to care, anytime a person is ready to come back.

Care Grounded in Science and Evidence

Our in-house, CLIA-accredited laboratory, located in Phoenix, Arizona, uses cutting-edge, validated methods of testing. We strive to be an innovative leader in support of early detection and intervention, especially for patients who may not engage with traditional medical care due to stigma, shame or lack of access.

With over 70% of all healthcare decisions driven by diagnostics, our in-house lab makes us more responsive, more efficient, and more accountable — all while controlling cost and improving access, while only conducting lab tests that are essential to improving quality of care. We view labs as an additional tool to provide best in class care, providing objective data to help our clinicians make medical decisions.

Here are just a few of the incredible achievements of the CMS Lab, in partnership with our experienced team of nurses and medical providers:

Processed over 4 million tests in 2025, representing approximately 350,000 orders

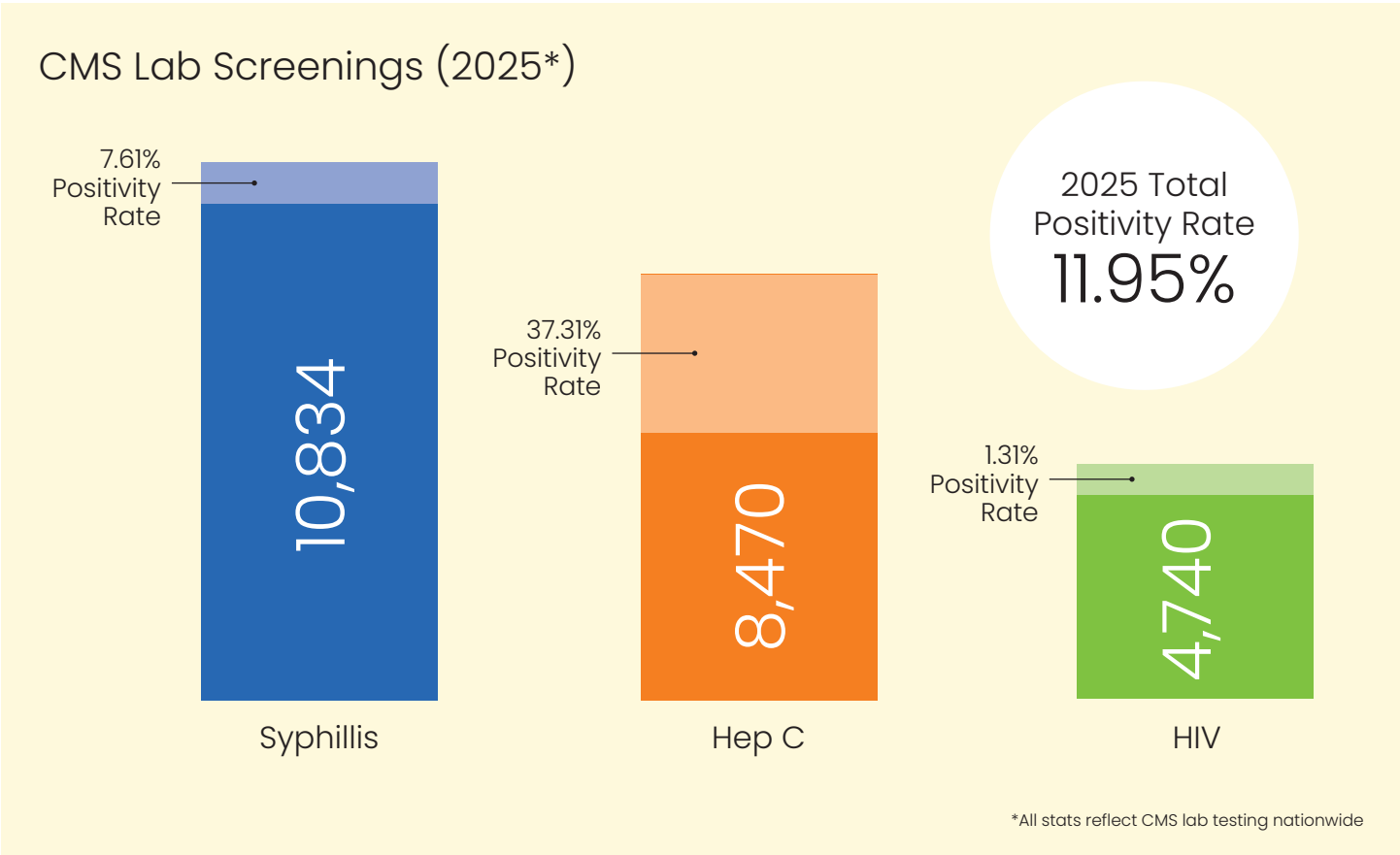
Completed ~7,200 in-house STI screenings during our first year launch

Launched STI screening at nearly all of our 70+ clinics

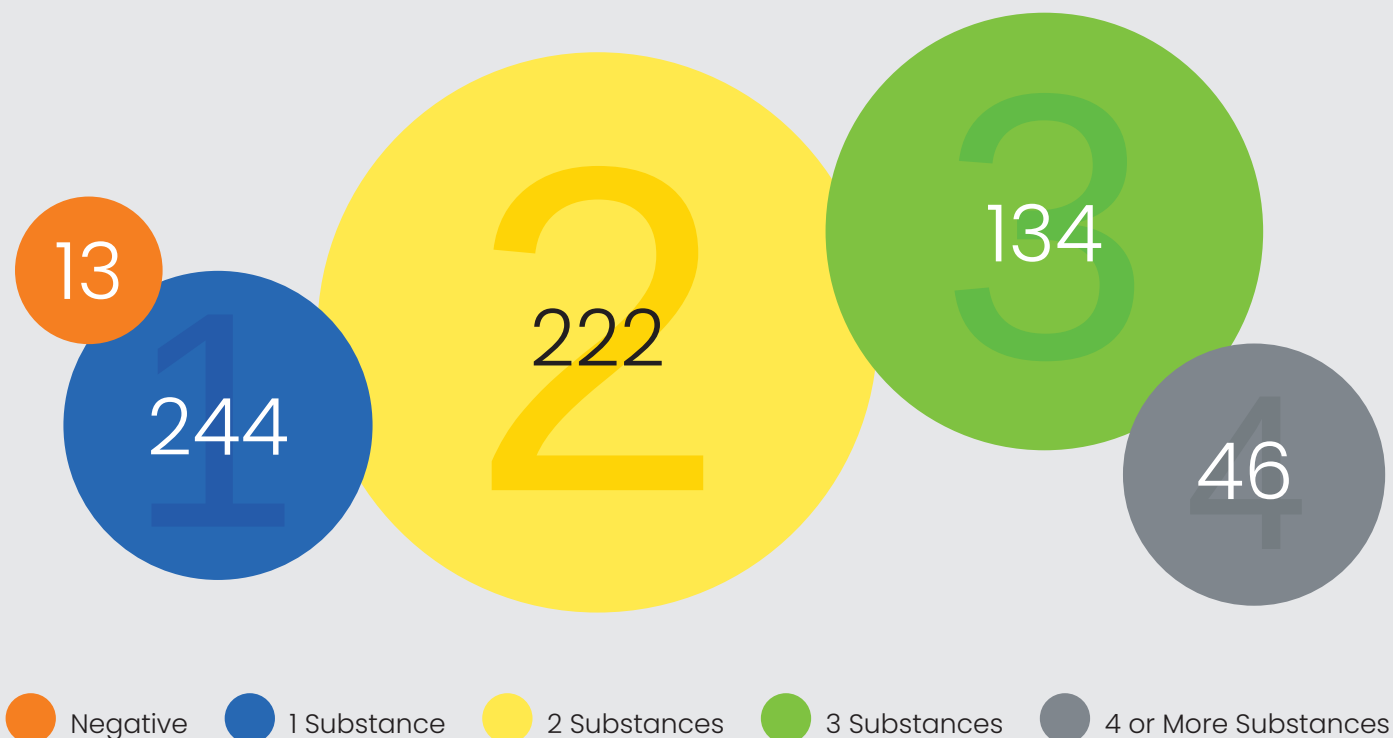
Internalized new offerings such as liver enzymes, routine urinalysis and hematological testing



Polysubstance Use

Toxicology results upon enrollment reflect evolving substance use patterns. Community Medical Services data aligns with broader reporting that shows increased use of synthetic substances and shifts in drug supply and trafficking patterns. Most new or returning patients test positive for multiple substances, and many are unaware of all substances they have been exposed to.

Fentanyl continues to dominate the illicit drug supply, well above heroin and prescription opioids, which dominated supplies in the early-mid 2000s. In 2025, street drugs increasingly contained a range of inexpensive synthetic compounds—often including fentanyl and fentanyl analogs—present in counterfeit pills and powders with varying and dangerous combinations and potencies. The use of stimulants and sedatives remains widespread. Cocaine also remains prevalent in many markets, also frequently contaminated with other substances, including fentanyl benzodiazepines,

commonly prescribed for anxiety and related conditions. Illicitly manufactured benzodiazepines—highly potent and frequently contaminated with fentanyl—pose elevated risks, particularly when used in combination with opioids. In addition, xylazine, a veterinary tranquilizer that is not currently a controlled substance, is increasingly detected in fentanyl containing pills and powders. Like benzodiazepines, xylazine increases the risk of respiratory depression and does not respond to naloxone, complicating overdose prevention and response efforts.

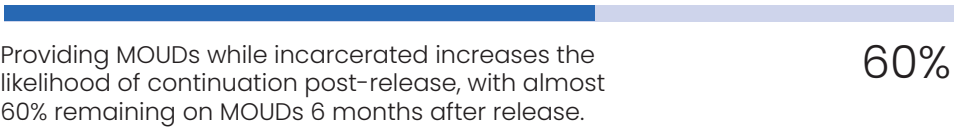
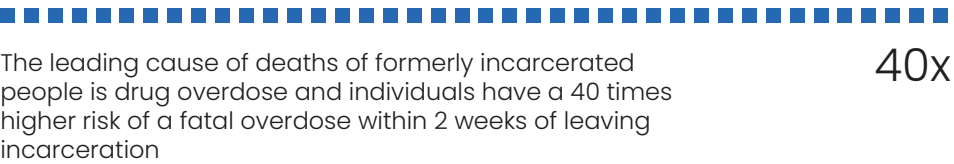
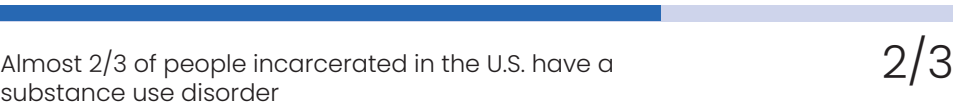


Correctional Health

At CMS, we believe that all people, regardless of incarceration status, deserve fair and equitable healthcare. Our innovative correctional health programs are at the very core of our Mission, Vision, and Values. These programs help eliminate the consequences of substance use disorders in the communities we serve across the country.

In 2010, CMS began supporting pregnant inmates with medication-assisted treatment in Maricopa County Jail in Arizona. Since then, our team has expanded to treat incarcerated individuals at prisons on both the state and federal level. Each program is tailored to meet the unique needs of the population it serves. By providing MOUD to incarcerated persons across the country we help ensure continuity of care as well as help reduce the risk of a fatal overdose for a group that is at high risk of such an event.

Our dedicated correctional health team also helps guide patients and advocates through drug courts, specialty courts, re-entry centers and transitional housing facilities to aid in ensuring individuals leaving incarceration are able to access treatment in a timely manner. We also look beyond treatment to educate and advocate.

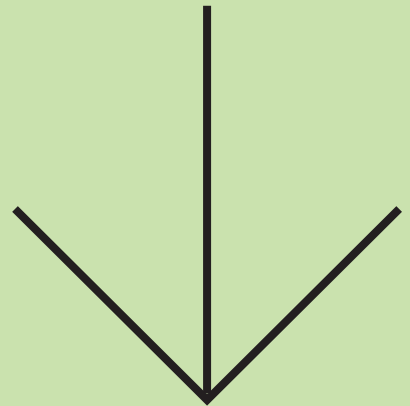

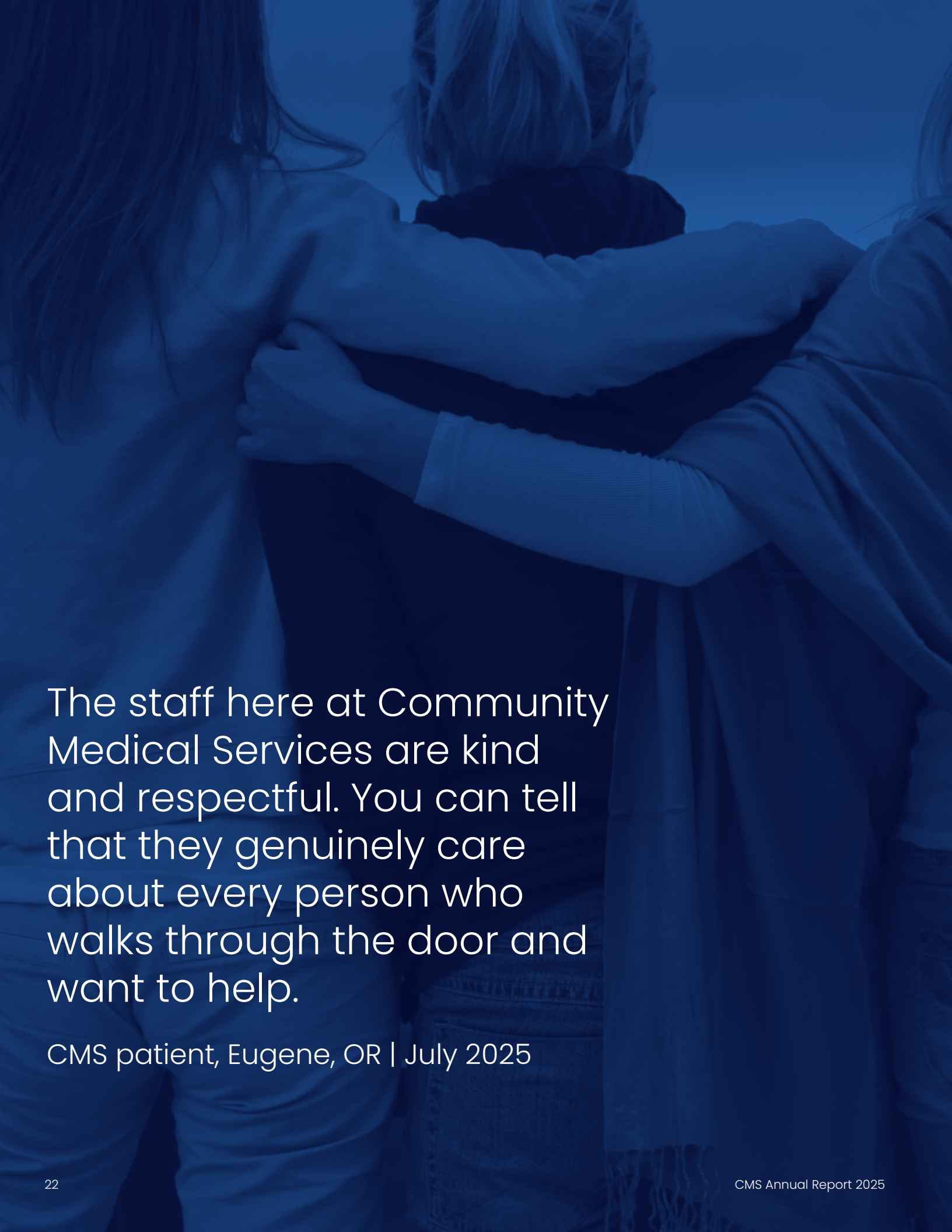
